Why: Because it will be fun to be with friends and an opportunity to learn something new.

How: Bring Simplicity pattern number 4025 or a similar pattern that fits you.

The Simplicity pattern will fit bust sizes of 30 inch to 46 inches. Since it is a simple pattern, it can be enlarged to fit one size larger. We will be making style A or C.

3 yards of quilted focus cotton fabric 45" wide.

3 yards of muslin 45" wide.

Scraps of fabric to coordinate with focus fabric.

Sewing machine with thread to match fabric.

Optional: 6 yards of novelty braid not more than 3/8" wide.

Patten Ease, (this is in the interfacing section of a quilt store. Any non-woven cheap interfacing will work to trace your pattern onto if pattern ease is not available.)

Ultra fine sharpie marker

12 to 24 inch clear ruler

Scissors

Straight pins

Please let me know if you can bring a crock-pot of soup to share with others? We will also need bread, butter and bowls to share lunch with our fellow quilters.

Our goal is to have the jackets finished for the Fall Fashion Show to be presented by Starlight Piecemakers. More information will be coming shortly.

Quilt Restoration Information

The soap & soak: Orvus & Restoration -Alice showed at the April day quilt guild meeting were from the Quilt Restoration workshop she attended in Omaha, NE.

It is recommended to do a prewash of your quilt or antique linens with Orvus soap; that may/will remove a lot of the yellowing. If yellowing stains remain, soak with Restoration (directions are on the bottle). Then do a final wash with Orvus. Restoration is not a soap. If there is enough interest, I would order the Restoration soak.

Interesting Facts About Quilting

The following facts about the guilting industry appeared in the Winter 2007 issue of Professional Quilter Online. To read more of the article, you may start a subscription at www.professionalguilter.com.

Every three years Quilts Inc. and Quilters Newsletter commission a survey to determine the size and dollar value of the quilting industry. They also look in-depth at 2500 gualified dedicated guilters to learn more about their buving habits. Here are some of the key survey findings:

- ★ Total U.S. guilting industry value is \$3,300,000,000 (\$3.3 billion).
- ★ Total guilters now exceed 27.7 million, which represents a more than 30 percent increase from the 21 million guilters reported in 2003.
- ★ Dedicated guilters spend on average \$2,304 per year on guilting for a total of \$2.89 billion, up 34.6 percent since 2003.
- ★ Dedicated quilters estimate the average dollar value of their "stash" to be \$3,195 and their guilting tools and supplies to be \$6,517.
- ★ The majority of dedicated quiltmakers (89%) own personal computers, with 73% having high-speed access. They spend an average of 2.2 hours per week on guilting Web sites. The primary reasons for activity are to get free patterns, learn about guilting products, shop for quilting supplies, find block patterns and search for fabrics.
