Kimberlee Diamond is an award winning guilter, established Statler longarm owner, teacher and business woman. Launching her career in 1998, Kim founded

the quilt company Sweet Dreams Quilt Studio where she primarily quilted for others. After struggling to find patterns for her own clients, she became one of the first computer designers in the longarm industry to begin creating and im-



plementing pattern drawings via the Statler Stitcher. Since the launch of her designing, Kim has taken her company to the international level and has traveled and taught worldwide. She has become one of the leading pattern designers in the industry and with a passion for learning and teaching was instrumental in starting and leading the SUGAR conference which is the first training intensive conference of its kind specific to Statler users. Kim also started the Certified Training program with Paul Statler and has implemented and written the training program exclusive to Statler Stitcher. In 15 years, her business has developed and grown to new heights all while teaching others innovative ways to make the most of their Statler.

Four years ago Kimberlee Diamond and JoAnn Blade joined forces. Their collaborative show guilts have won them many awards. All of these quilts have been 100% appliquéd on a computerized longarm quilting machine. Their quilts have been in magazines, on covers and in fliers for quilt shows and TV shows as well.

Kim's trunk show will take you from her humble beginning through the present show quilts. Her quilt "Serengeti" recently won Best of Show at the 2015 SUGAR Conference.

SPRING CLEANING IN THE FALL

This is a long awaited plan to make sales space available to members who wish to rent a table space. The deadline for reserving space is October 31. The table rental is \$25 for one table and \$40 for two tables. Sale items should be related to quilt making and may include books, magazines, fabric, quilt tops, blocks and quilts, either new or vintage/antique. Each member is responsible for his or her own change fund, sales and table set up. There is

a maximum of ten tables available. Two tables is the limit per member. Members may arrange on their own to share a table. If you have previously mentioned that you want a table you must still contact her for confirmation. Table set up is 8-9 a.m. on the meeting day and sales are from 9-noon. Rental fees will go to Day Chapter programs.

The tables must be cleared before the general meeting as the election staff will need access immediately after the chapter meeting ends.
