It was announced that the building contract for the Quilt Show has been signed. Long sleeved tee shirts are available for the Quilt Show at a cost of \$20. Quilt Show times were set for 9-5 on both Friday and Saturday. It was moved by Pegg Brothers and seconded by Martha Eberhard to charge \$5 admission to the show. The motion carried.

It was announced that Judi Kirkpatrick and Linda Karns completed an equipment inventory.

Alice Leeper presented proposed changes to the Policies of Booneslick Trail Quilters' Guild. It was moved by Alice Leeper and seconded by Martha Eberhard to accept the policies as presented.
